1. Meeting called to Order

The meeting was called to order at 9:33am.

2. Confirmation of Minutes

The Secretariat will follow up on the MOU with the Office of the Ombudsman, which is seeking a new Head, and with WORC.

e. ACC staff training

The Trainee Investigator is participating in the RCIPS Recruit training program as a part of the ACC's continued partnership with RCIPS. The ACC Analyst is participating in an IACCC training course in the UK as part of our associate membership with the IACCC.

6. C-FATF Related Updates

The ACC Chairman and the Senior Investigator continue to attend CFATF meetings as required. The Secretariat will continue to submit quarterly statistics as required.

There were seven new report/complaint to be considered as follows:

- vi. ACC/COMP/2021/013 the matter was closed.
- vii. ACC/COMP/2021/015 the matter was closed.
- viii. ACC/COMP/2021/016 the matter is closed as it doesn't meet the ACC threshold.
- ix. ACC/COMP/2021/005 Follow up is needed

b. Existing Corruption Reports/Complaints

The Commission was informed that since inception (1st Jan. 2010) there have been 154 investigations registered by the Commission, of which:

- i. 3 are 'pending' awaiting further or sufficient information which may make it appropriate to make further investigations;
- ii. 132 have been concluded (or have not met the threshold or fallen under the remit of the Commission);
- iii. 10 have been transferred to other investigative units for action;
- iv. 9 are now under current active investigation; and
- v. 0 is being assessed/considered.

The internal spreadsheet which provides details of the investigations will continue to be updated on a monthly basis.

9. Any Other Business

a. It was agreed that persons should be encouraged to complete the Complaints Report Form.

10. Action Items

- a. Member Gus Pope will follow-up regarding the amendments to the Anti-Corruption Act;
